Citizen Advisory Committee (CAC) – 1st Semester General Report

In October 2022, after receiving recommendations from community leaders and nongovernmental organizations, and in compliance with dispositions published by HUD in the Federal Register, 84 FR 45838-45853, the Citizen Advisory Committee (CAC) was constituted. This work group extends citizen participation to initiatives under the Community Development Block Grant Mitigation subvention (CDBG-MIT). Considering criteria related to representation, diversity, trajectory, closeness to communities and expert knowledge, 15 members were formally designated. The CAC's composition is as follows:
