This AMENDMENT A TO EQUIPMENT LOAN AGREEMENT (this "Amendment), dated as of the 4th day of November, 2024, by and between TIBER HEALTH, PUBLIC BENEFIT CORPORATION, doing business as Ponce Health Sciences University, a public benefit corporation organized and existing under the laws of the State of Delaware and duly authorized to do business in the Commonwealth of Puerto Rico (the "Borrower"), represented herein by David Lenihan, of legal age, married, executive and resident of San Juan, Puerto Rico; TIBER HEALTH CORPORATION, a corporation organized and existing under the laws of the State of Delaware, represented herein by David Lenihan, of legal age, married, executive and resident of San Juan, Puerto Rico, and TIBER PONCE HOLDINGS, LLC, a limited liability company organized and existing under the laws of the State of Delaware, represented herein by David Lenihan, of legal age, married, executive and resident of San Juan, Puerto Rico, (collectively, the "Guarantor"); and the PUERTO RICO DEPARTMENT OF HOUSING (the "Lender"), a public agency of the Government of Puerto Rico created under Act No. 97, of June 10, 1972, as amended, known as the "Department of Housing Organic Act" (the "Organic Act"), with principal offices at 606 Barbosa Avenue, San Juan, Puerto Rico, represented herein by José M. Olmo Terrasa, of legal age, married, attorney, and resident of San Juan, Puerto Rico (hereafter "Parties").



WHEREAS, on April 14, 2023, the Parties entered into an Equipment Loan Agreement (the "Equipment Loan" or "Agreement") pursuant to the terms of the Community Development Block Grant – Disaster Recovery ("CDBG-DR"), Loan Agreement for Economic Development Investment Portfolio for Growth Program ("IPG"), the Lender has agreed, subject to the terms and conditions thereof, to make certain loan in the principal amount of up SIXTEEN MILLION TWENTY THREE THOUSAND FOUR HUNDRED THIRTY EIGHT DOLLARS (\$16,023,438.00) (the "Loan") to the Borrower; pursuant to Grant B-18-DP-72-0001, Activity Codes r02e24ecti-ppp03-lm and r02e24edippp03-un, Account Number 6090-01-000; in accordance with the published IPG Program guidelines, as amended from time to time (the "Program Guidelines"). All capitalized terms not defined herein shall have the meanings set forth in the Equipment Loan and the other Loan Documents;

**WHEREAS**, it is the intention of the Parties that this Amendment does not affect, nor does it constitute an extinctive novation of, the obligations of the Parties under the Equipment Loan, but rather serves as a modification and amendment of certain terms and conditions under the Equipment Loan;

**WHEREAS**, each party represents that the person executing this Amendment has the necessary legal authority to do so on behalf of the respective party.

#### SAVINGS CLAUSE

The information included in this Amendment serves the purpose of modifying and amending certain terms and conditions under the Equipment Loan, as established in Articles II, III and IV of this Amendment. All other provisions of the original Equipment Loan, including its attachments, shall continue to be in full force and effect.

#### II. SCOPE OF AMENDMENT

The goal of the Economic Development Investment Portfolio for Growth Program (**Program** or **IPG**) is to address the critical needs of businesses and residents of Puerto Rico by providing leveraged funding to support private investments to meet unmet economic development needs; supporting projects that will provide essential services; assisting with the economic revitalization and regional recovery of hurricane-impacted communities by investing in transformative community-based projects; spurring long-term job creation; meeting a recovery objective and creating long-term opportunities; and completing transformative, large-scale regional revitalization projects that will provide benefits to a wide range of Puerto Ricans;

In order to achieve the Program goals, the Parties acknowledge and agree that modifications are needed to amend certain sections of the Equipment Loan to among other things, (i) revise the definition of Conversion Date to provide for an extension up to September 30, 2025; and (ii) include the installation of Equipment in the Dental School (as such term is defined below) within the authorized uses of the Equipment Loan.

As stated before, all other provisions of the Equipment Loan, including the total authorized budget, remain unaltered.

## III. AMENDMENTS

A. Article I. Section 1.1 (Definitions) of the Equipment Loan is amended to revise and/or add the following definitions, which shall read as follows:

"[…]

"Completion Date" means the earlier of: (i) the date of substantial completion of the installation of the Equipment and the construction of the Improvements, or (ii) August 29th, 2025.

[...]

"Conversion Date" means the day on which the last Loan Advance is made but never later than September 30, 2025."

[...]

"Dental School" means that dental clinic and school to be developed on that certain property recorded in the Registry of Property of Puerto Rico, first (I) Section of Ponce, at page one hundred seventy-seven (177) of volume two thousand seventy nine (2,079), property number sixty four thousand thirty nine (64,039) of Ponce Norte, owned by the Borrower where the Equipment and Improvements will be installed."

"Equipment" means the equipment described in Schedule 1 to be acquired by Borrower with the proceeds of the Loan for: (i) installation in the auditorium, patient clinics, and dental simulation laboratory located within the Academic Center, and (ii) installation in the Dental School."

"Improvements" means the installation of the Equipment and work performed on the Academic Center and the Dental School with Loan funds.

[...]"

B. Article VII. (COVENANTS OF THE BORROWER), Section 7.1 of the Equipment Loan is hereby amended to incorporate subsection 7.1 (hh) which shall read as follows:

"(hh) Borrower shall comply with the following to ensure compliance with Davis Bacon and Related Acts and its implementing federal requirements expressed in 29 CFR 1,3 and 5 as cited in Section 7.1 (a) of the Loan Agreement.

- i. The Borrower will ensure the inclusion of the copy of Federal Wage Determination "General Decision Number PR20230001 01/06/2023" attached hereto as **Exhibit O** as an exhibit to contracts for the performance of construction, prosecution, completion or repair at the site of work on a building or work, as per 29 CFR 5.1 and 29 CFR 5.2.
- ii. The Borrower will ensure the inclusion of HUD Form 4010 (2023), which is attached hereto as Exhibit P, as an exhibit to contracts for the performance of construction, prosecution, completion or repair at the site of work on a building or work to the extent applicable, as per 29 CFR 5.1 and 29 CFR 5.2.
- iii. The Borrower is obligated to ensure any relevant local Puerto Rico executive orders and local laws affecting or updating wage rates are communicated in writing and made effective for covered parties including contractors and subcontractors.
- iv. The Borrower is responsible for complying with Davis Bacon and Related Acts policy guide, recordkeeping standards as well as Lender's Record Keeping, Management, and Accessibility Policy.
- v. The Borrower will ensure that covered project contractors or subcontractors respond promptly and effectively to Lender's compliance requests, including but not limited to contract provisions and related matters as indicated in HUD form 4010. This includes submission of payrolls, access to project contractor staff for onsite visits, and the timely implementation of corrective actions as specified by the Lender.
- C. An updated version of Exhibit C (HUD GENERAL PROVISIONS) is hereby incorporated by reference into the Equipment Loan and replaces the original Exhibit C (HUD GENERAL PROVISIONS) as part of the Equipment Loan (see **Attachment I** of this Amendment).
- D. Exhibit O (PHSU FEDERAL WAGE DETERMINATION) is hereby incorporated by reference into the Equipment Loan and made part of the Equipment Loan (see **Attachment II** of this Amendment).

E. Exhibit P (HUD FORM 4010 FEDERAL LABOR STANDARDS PROVISIONS) is hereby incorporated by reference into the Equipment Loan and made part of the Equipment Loan (see **Attachment III** of this Amendment).

#### IV. HEADING

The titles of the paragraphs of this Amendment are solely for reference purposes and the convenience of the Parties and shall not be used to explain, modify, simplify, or aid in the interpretation of the provisions of this Amendment.

#### V. FEDERAL FUNDING

The fulfillment of the Agreement, as amended, is based on those funds being made available to the PRDOH as the lead administrative agency for Recovery. All expenditures under the Agreement, as amended, must be made in accordance with the Agreement, as amended, the policies and procedures promulgated under the CDBG-DR Programs, and any other applicable laws. Further, the Borrower and Guarantor acknowledges that all funds are subject to recapture and repayment for non-compliance under the Agreement.

#### VI. ENTIRE AGREEMENT



The Agreement and this Amendment constitute the entire agreement among the Parties for the use of funds received under the Agreement, and it supersedes all prior or contemporaneous communications and proposals, whether electronic, oral, or written among the Parties with respect to the execution of this Amendment.

### VII. SEVERABILITY

If any provision of this Amendment is held or made invalid or shall operate or would prospectively operate to invalidate the Amendment in whole or in part, then such provision only shall be deemed severed and the remainder of the Amendment shall stay operative, in full effect and enforceable.

### VIII. SURVIVAL OF TERMS AND CONDITIONS

The terms and conditions of this Amendment related to the following subjects shall survive the termination or expiration of this Amendment: interpretive provisions; consideration; warranties; general affirmations, federal assurances, federal and state certifications; CDBG-DR and state funding, recapture of CDBG-DR and/or state funds, overpayment of CDBG-DR and/or state funds; ownership and intellectual property, copyright; records retention methods and time requirements; inspection, monitoring, and audit; confidentiality; public records; indemnification and liability; infringement of intellectual property rights; independent contractor relationship; compliance with laws; notices; choice of law and venue; severability; dispute resolution; consolidations, merger, change of name, and dissolution. Terms and conditions that, explicitly or by their nature, evidence the Parties' intent that they should survive the termination or expiration of this Amendment shall so survive.

This Amendment is acknowledged and agreed by each of the undersigned. Each undersigned hereby confirms and ratifies all its obligations and liabilities, and all liens and guaranties, provided in the Loan Documents executed by the undersigned, all of which shall continue in full force and effect in accordance with their respective terms, notwithstanding the execution of this Amendment or any other document relating to such Amendment.
