AMENDMENT D TO THE SUBRECIPIENT AGREEMENT BETWEEN THE PUERTO RICO DEPARTMENT OF HOUSING AND THE MUNICIPALITY OF VIEQUES

This **AMENDMENT D TO THE SUBRECIPIENT AGREEMENT** (**AMENDMENT D**) is entered into this <u>18</u> day of <u>June</u>, 2025, by and between the **PUERTO RICO DEPARTMENT OF HOUSING** (**PRDOH**), a public agency of the Government of Puerto Rico created under Act No. 97, of June 10, 1972, as amended, 3 LPRA § 441 *et seq.*, known as the "**Department of Housing Organic Act**" (**Organic Act**), with principal offices at 606 Barbosa Ave., San Juan, Puerto Rico, represented herein by Ciary Y. Pérez Peña, of legal age, single, and resident of Las Piedras, Puerto Rico, in her capacity as Secretary; and the **MUNICIPALITY OF VIEQUES** (**Subrecipient**), a local government legal entity, with principal offices at Vieques, Puerto Rico, represented herein by its Mayor, José A. Corcino Acevedo, of legal age, married, and resident of Vieques, Puerto Rico; duly authorized to represent the Municipality by the provisions of the Puerto Rico Municipal Code, Law No. 107 of August 14, 2020, collectively the "**Parties**".

I. RECITALS AND GENERAL AWARD INFORMATION

WHEREAS, on May 26, 2021, the PRDOH and the Subrecipient executed a Memorandum of Understanding, registered as Contract Number 2021–DR0246 (Agreement), for ONE HUNDRED SEVENTY-ONE THOUSAND EIGHT HUNDRED NINETY-THREE DOLLARS AND NINETY-SEVEN CENTS (\$171,893.97) to provide the Subrecipient with the capacity to successfully assume the delegated functions, including recruiting resources that will be in charge of carrying out administrative tasks related to programmatic compliance efforts. The Parties agreed on a performance period of twenty-four (24) months from the day of the execution of the Agreement, ending on May 26, 2023.

WHEREAS, on March 16, 2023, the Parties agreed to amend the Agreement through Amendment A, registered as Contract Number 2021–DR0246A, to extend the term for an additional twelve (12) months, ending on May 26, 2024. The budget of the Agreement was not modified by Amendment A. Modifications to Section III. GENERAL AWARD INFORMATION table, Section IV. ATTACHMENTS, Section VII. EFFECTIVE DATE AND THE TERM, Section XII. COMPLIANCE WITH FEDERAL STATUTES, REGULATIONS, AND THE TERMS AND CONDITIONS OF THE FEDERAL AWARD AND ADDITIONAL PROOH REQUIREMENTS, and Section XIII. CDBG-DR POLICIES AND PROCEDURES were included. Also, Section XXXV. SYSTEM FOR AWARD MANAGEMENT (SAM) REGISTRATION and

Section XXXVI. LIMITATIONS PENDING ENVIRONMENTAL CLEARANCE were added to the Agreement. Furthermore, an updated version of Exhibit C (HUD General Provisions and Other Federal Statutes, Regulations, and PRDOH Requirements), and a new Exhibit D (Non-Conflict of Interest Certification) were incorporated by reference into the Agreement. All other provisions of the original Agreement remained unaltered.

WHEREAS, on May 15, 2024, the Parties agreed to amend the Agreement through Amendment B, registered as Contract Number 2021-DR0246B, to extend the term ending on December 31, 2024. Modifications to Section III. GENERAL AWARD INFORMATION table, Section VII. EFFECTIVE DATE AND THE TERM, and Section XVI. CONSOLIDATIONS, MERGERS, CHANGE OF NAME, OR DISSOLUTIONS were included. Also, Section XXXVII. PUERTO RICO POLITICAL CAMPAIGN FINANCING OVERSIGHT ACT was added to the Agreement. Furthermore, updated versions of Exhibit C (HUD General Provisions and Other Federal Statutes, Regulations, and PRDOH Requirements), and Exhibit D (Non-Conflict of Interest Certification) were incorporated by reference into the Agreement. All other provisions of the original Agreement, including the total budget amount, remained unaltered.

CYPP CYPP WHEREAS, on December 27, 2024, the Parties agreed to amend the Agreement through Amendment C, registered as Contract Number 2021–DR0246C, to extend the term ending on June 30, 2025. Modifications to Section III. GENERAL AWARD INFORMATION table and Section VII. EFFECTIVE DATE AND THE TERM were included. Furthermore, updated versions of Exhibit C (HUD General Provisions and Other Federal Statutes, Regulations, and PRDOH Requirements) and Exhibit D (Non-Conflict of Interest Certification) were incorporated by reference into the Agreement. All other provisions of the original Agreement, including the total budget amount, remained unaltered.

WHEREAS, as per Section IX (A) of the Agreement, the Agreement may be amended in writing and signed by a duly authorized representative of each party. Nonetheless, the amendment shall not invalidate the Agreement, nor release the Parties from their obligations under the Agreement.

WHEREAS, this **AMENDMENT D** does not constitute an extinctive novation of the obligations of the parties under the Agreement.

WHEREAS, the PRDOH has the legal power and authority, in accordance with its enabling statute, the Organic Act, the Federal laws and regulations creating and allocating funds to the CDBG-DR Program, and the current Action Plan, to enter into this **AMENDMENT D**.

WHEREAS, the Subrecipient has the legal power and authority to enter into this AMENDMENT D with the PRDOH, in accordance with Article 1.008 of Act No. 107 of August 14, 2020, also known as the "Puerto Rico Municipal Code"; and by signing this

AMENDMENT D, the Subrecipient assures the PRDOH that it shall comply with all the requirements described herein.

NOW, THEREFORE, in consideration of the mutual promises and the terms and conditions set forth herein, the PRDOH and the Subrecipient agree to execute this **AMENDMENT D** subject to the following:

II. TERMS AND CONDITIONS

A. SAVINGS CLAUSE

The information included in this **AMENDMENT D** serves the purpose of modifying and amending certain terms and conditions under the Agreement, as well as modifying or incorporating several exhibits, as established in the following sections B and C of this **AMENDMENT D**. All other provisions of the original Agreement, including its exhibits, shall continue to be in full force and effect.

B. SCOPE OF THE AMENDMENT

The Parties acknowledge and agree that this **AMENDMENT D** entails a modification of the **PERIOD OF PERFORMANCE** and **END DATE** of the Agreement. To achieve the Program goals, the Parties acknowledge and agree that it is necessary to amend the **END TERM** of the Agreement to **June 30, 2026**.

Also, modifications and changes to the **GENERAL AWARD INFORMATION** table in **Section III**, **Section VII**. **EFFECTIVE DATE AND TERM**, and **Section X**. **NOTICES** of the Agreement are being incorporated via this **AMENDMENT D**.

Finally, an updated version of **Section XIII. CDBG-DR POLICIES AND PROCEDURES, Section XXXI. RECAPTURE OF FUNDS** and **Exhibit D** (Non-Conflict of Interest Certification) of the Agreement are being incorporated via this **AMENDMENT D.** All other provisions of the original Agreement, including the total budget amount, remain unaltered.

b. **Section VII. EFFECTIVE DATE AND TERM** of the Agreement is being amended as follows:

This Agreement shall be in effect and enforceable between the parties from the date of its execution. The performance period of this Agreement extends from the date of its execution, ending on **June 30, 2026**.

The End of Term shall be the later of: (i) **June 30, 2026**; (ii) the date as of which the Parties agree in writing that all Close-Out Requirements¹ have been satisfied or, where no Close-Out Requirements are applicable to this Agreement, the date as of which the Parties agree in writing that no Close-Out Requirements are applicable hereto; or (iii) such later date as the Parties may agree to in a signed amendment to this Agreement.

¹ "Close-Out Requirements" means all requirements to be satisfied by each party in order to close-out this Agreement and the CDBG-DR funds provided herein in accordance with applicable Requirements of Law, including the execution and delivery by one or more of the Parties of all close-out agreements or other legal instruments and the taking of any actions by one or more of the Parties in connection with such close-out, in any case as required under applicable Requirements of Law.

d. The Parties agree to modify **Section XIII. CDBG-DR POLICIES AND PROCEDURES** as follows:

In addition to what is established in this SRA, the Subrecipient shall comply with all CDBG-DR/MIT program-specific and general policies and procedures, which may include but are not limited to, the Subrecipient Management Policy, OS&H Guideline, MWBE Policy, URA & ADP Guidelines, Cross Cutting Guidelines, AFWAM Policy, Section 3 Policy, Personally Identifiable Information, Confidentiality, Language Access Plan, and Nondisclosure Policy and Conflict of Interest and Standards of Conduct Policy, as found CDBG-DR/MIT in the Website (https://recuperacion.pr.gov/en/resources/policies/), which are herein included and made an integral part of this SRA, as they may be updated from time to time, Procurement policies and procedures in accordance with the Procurement Manual for the CDBG-DR, CDBG-MIT, and CDBG State Programs Regulation No. 9506 (effective on October 25, 2023), and reporting requirements as established by the PRDOH.

e. The Parties agree to modify **Section XXXI. RECAPTURE OF FUNDS** as follows:

PRDOH may recapture payments it makes to Subrecipient that: (i) exceed the maximum allowable rates; (ii) are not allowed under applicable laws, rules, or regulations; or (iii) are otherwise inconsistent with this Agreement, including any unapproved expenditures. Subrecipient must refund such recaptured payments within the term specified by PRDOH via notification, as per CDBG-DR/MIT Program Recapture of Funds Policy. (Recapture of Funds Policy - CDBG-DR/MIT Recovery Funds).

f. **Exhibit D** (Non-Conflict of Interest Certification) of the Agreement is being replaced by an updated version. (See **Attachment I**).

III. SEVERABILITY

If any provision of this **AMENDMENT D** is held invalid, the remainder of **AMENDMENT D** shall not be affected thereby, and all other parts of this **AMENDMENT D** shall nevertheless be in full force and effect.

IV. SECTION HEADINGS AND SUBHEADINGS

The section headings and subheadings contained in this **AMENDMENT D** are included for convenience only and shall not limit or otherwise affect the terms of the Agreement, and shall not be used to explain, modify, simplify, or aid in the interpretation of the provisions of this **AMENDMENT D**.

V. COMPTROLLER REGISTRY

The PRDOH shall remit a copy of this **AMENDMENT D** to the Office of the Comptroller for registration within **fifteen** (**15**) **days** following the date of execution of this **AMENDMENT D** and any subsequent amendment thereto. The services object of this **AMENDMENT D** may not be invoiced or paid until this **AMENDMENT D** has been registered by the PRDOH at the Comptroller's Office, under Act No. 18 of October 30, 1975, as amended by Act No. 127 of May 31, 2004.

VI. ENTIRE AGREEMENT

The Agreement, as amended, constitutes the entire Agreement among the Parties for the use of funds received under the Agreement, as amended, and it supersedes all prior or contemporaneous communications and proposals, whether electronic, oral, or written among the Parties concerning the Agreement, as amended.

VII. FEDERAL FUNDING

The fulfillment of the Agreement, as amended, is based on those funds being made available to the PRDOH as the lead administrative agency for Recovery. All expenditures under the Agreement, as amended, must be made in accordance with the Agreement, as amended, the policies and procedures promulgated under the CDBG-DR Program, and any other applicable laws. Further, the Subrecipient acknowledges that all funds are subject to recapture and repayment for non-compliance.

VIII. NON-CONFLICT OF INTEREST CERTIFICATION

The Subrecipient reassurances PRDOH of its willingness to comply with the applicable conflict of interest policies by signing the Non-Conflict of Interest Certification incorporated by reference into the Agreement by this **AMENDMENT D (ATTACHMENT I).**





IX. COMPLIANCE WITH ADMINISTRATIVE ORDER NO. OA-HD-25-03 OF PRDOH

On April 28, 2025, PRDOH issued an Administrative Order No. OA-HD-25-03, to establish public policy regarding the use and management of electronic and digital signatures within PRDOH. Additionally, to recognize electronic and digital signatures in the course of PRDOH's operations.

In compliance with OA-HD-25-03, PRDOH validates the consent of the electronic signatories through the incorporation of the following clause:
